1. Southeast Regional Maintenance Center hosted the annual Standard Specification for Ship Repair and Alteration Committee (SSRAC) meeting 17-19 July 2007, in Jacksonville, Florida. Final FY-09 NAVSEA Standard Items (SI) and Appendix 4-E of the Joint Fleet Maintenance Manual (JFMM) Volume VII, Chapter 4, as well as a list of comments received on the preliminary package and the resulting actions, are available on the official SSRAC web site. The FY-09 Standard Items and Standard Phraseology (Section A) shall be invoked for all CNO availabilities with an availability start date in FY-09 and in all other (CMAV and emergent) new procurements issued after **1 February 2008**. Standard Phraseology (Sections B-G) changes are effective upon receipt.


3. SSRAC Coordinators are responsible for advising users within their respective activities and MSR contractors under their cognizance of the availability of these products.

4. The Master Specification Catalog Maintenance Office should ensure that phraseology changes as well as Table/Line changes resulting from the revisions to SI 009-32 are incorporated into the Standard Work Templates and Class Standard Work Templates.

5. The requirements of this letter do not authorize any change in terms, conditions, delivery schedule, price, or amount of any Government contract.
